

Pre-paid smart meters for all govt electricity connections from August

Bhubaneswar, 18 July:

To further leverage the benefits of smart metering, all Government electricity connections will be converted from post-paid to pre-paid smart meters with effect from August, stated officials after a Board Meeting of the Discoms chaired by Chief Secretary Anu Garg.

Government consumers adopting pre-paid smart metering will be eligible for a 4 per cent rebate on their



monthly electricity bills.

The Board reviewed the progress under PM Surya Ghar Muft Bijli Yojana and noted that all the four discoms – TPCODL, TPNODL, TPSODL and TPWODL had together achieved a total of 1,56,606 rooftop solar installations including 92,280 under

PM-SG-MBY and 64,326 under the ULA scheme. Odisha is among the top ten performers in the country under the programme.

The review focused on renewable energy initiatives, operational efficiency, network strengthening and smart metering.

Among others, Additional chief secretary Vishal Kumar Dev, CMD, GRIDCO, and the Board Members/ Managing Directors/CEOs/ CFOs of all four DISCOMs attended the meeting.

The Chief Secretary also directed the DISCOMs to

expedite implementation of the PM-KUSUM 2.0 scheme to further strengthen renewable energy adoption across the State.

The Board appreciated the sustained reduction in Aggregate Technical and Commercial (AT&C) and financial performance.

The DISCOMs were appreciated for ensuring uninterrupted, safe and reliable electricity supply during Rath Yatra 2026.

Capital expenditure undertaken by the four DISCOMs over the last five years was reviewed.

Case of missing files: Ex-IT secretary Manoj Mishra appears before police

Former Odisha Information Technology (IT) secretary Manoj Mishra appeared before police here on Saturday in connection with the investigation into a case of missing files from the CMO in 2024.

The two files relating to the commission report on assassination of VHP leader Laxmananda Saraswati and an RDC probe report on a fire at a private hospital were reportedly missing and the

state Home Department had lodged an FIR.

The police had summoned Mishra and retired IAS officer Rajesh Verma on 22 July. Mishra sought preponement of the date and appeared today.

Replying to questions, Mishra told media persons that as part of the investigation police are questioning officials who were in charge or associated with the CMO during the relevant period. I am cooperating with the ongoing investigation, he added.

Five injured in wild boar attack

Kendrapara, 18 July:

Five persons, including a woman, were injured when a wild boar attacked them in Satiabati village under the Mahakalapada forest range near Bhitarkanika National Park in Kendrapara district on Friday evening.

The victims were returning from their paddy fields after completing farming work when the animal suddenly charged at them, inflicting deep puncture wounds before trampling the victims with

its hooves, villagers said.

The injured were identified as Panchel Das (43), Dhanu Samal (28), Bipain Swain (32), Pratap Behera (60), and Damodar Rout (25). They were admitted to the Community Health Centre (CHC) at Mahakalapada, where they are undergoing treatment.

Mahakalapada Forest Range Officer Santanu Kumar Dalei said the forest department would conduct an inquiry into the incident before extending compensation to the victims.

Two electrocuted in farm land

Two people died allegedly after coming in contact with a live electric fence in a farm field near Mahishapanda village under Simulia police limits in the district.

According to locals, the fence had been set up by Babul Das to protect his paddy seedlings from stray cattle and cows. On Monday evening, he connected the wire to a live power source. Today, unaware that the current was still on, Babul Das entered the field and came in contact with the wire. He suffered an electric shock and collapsed. An elderly woman from a nearby house, Parbati Munda, rushed to help him. She too was electrocuted upon touching him. Both died on the spot.

Locals cut off the power supply and informed the fire station and ambulance services. Fire department personnel retrieved the bodies from the field and sent them to the Simulia Community Health Centre in an ambulance. Police have registered a case and are investigating the incident.
