

Gyanvapi row can't be settled by mediation: Mosque panel

Varanasi: The Anjuman Intezamia Masajid (AIM), which manages the Gyanvapi mosque, has declined the Supreme Court's proposal to explore an amicable settlement of the Gyanvapi dispute through mediation during the proposed Special Lok Adalat in Aug, saying the matter is too sensitive to be resolved through conciliation and should be decided solely through the judicial process.

Reacting to the Supreme Court's "Samadhan Samaroh 2026" initiative, under which litigants have been invited to pre-conciliation meetings ahead of the Special Lok Adalat scheduled from Aug 21, Anjuman Intezamia Masajid joint secretary S M Yasin said on Monday that the mosque committee had collectively decided not to participate in the process.

"Our stand is clear. Although the process is voluntary and based on consent, we have decided not to participate. The Gyanvapi dispute is a highly sensitive matter and will be contested only through the judicial process and in accordance with law," Yasin said.

Anjuman Intezamia Masajid joint secretary S M Yasin added that while the committee respects peaceful resolution of disputes, issues involving the Gyanvapi mosque,

ownership rights and the Places of Worship (Special Provisions) Act, 1991 should be adjudicated by courts rather than through mediation or Lok Adalat proceedings.

He added that the Muslim side would not relinquish its claim to the mosque and, therefore, saw no justification for participating in conciliation talks.

Several cases relating to the Gyanvapi dispute are currently pending before courts. The oldest, Original Suit No. 610 of 1991, seeking the removal of the mosque from the disputed site, is being pursued by advocate Vijay Shankar Rastogi as the "next friend" of the deity and is pending before a fast-track court.

Significant developments took place between 2022 and 2024 in Suit No. 693 of 2021 (later renumbered as Suit No. 18 of 2022 after its transfer to the district judge's court), filed by Rakhi Singh and Others seeking the right to worship Shringar Gauri within the Gyanvapi complex. During this period, the court ordered an ASI survey. The Archaeological Survey of India submitted its report, and worship was also permitted in the southern cellar of the complex. Several other individuals and organisations have also filed petitions or sought to be impleaded in the ongoing litigation. However, there were no major developments in the Gyanvapi cases in 2025.

Meerut: After Supreme Court's "mediation" proposal, Sambhal Shahi Jama Masjid sadar Zafar Ali said the mosque committee is not currently considering it and will decide on further steps only after receiving any formal notice.

"We are ready to sit for talks; however there is no situation in which we would agree to a settlement, because we had already won the case in 1877," Ali told TOI.

The SC had recently written to contesting parties in Sambhal Jama Masjid dispute, inviting them to explore an amicable settlement under its mediation initiative, ahead of a special Lok Adalat scheduled from Aug 21 to 23. However, the Hindu litigants and the mosque management committee, in the case, have since informed SC and district legal services authorities that they are not inclined to participate in the process, effectively ruling out the dispute from being taken up at the special sitting next month.

Vishnu Shankar Jain, plaintiff of Hindu side told TOI: "I'm not ready for any mediation."

Solved hit & run case in 48 hrs: U'khand cops

Rudrapur: A premeditated murder that was staged as a hit-and-run road accident has been cracked within 48 hours by Udhham Singh Nagar police, leading to the arrest of two suspects and the recovery of the vehicle used in the crime.

The crime happened on July 10, when police received an emergency call that a car had rammed a motorcycle near Thakurdwar Chungi on Kheda Road in Jaspur. Sources said the final report will not merely identify the individuals directly involved in the alleged theft but also examine the chain of accountability that enabled the alleged embezzlement to continue undetected. Investigators are expected to determine whether supervisory officers, administrative functionaries and officials responsible for monitoring donation

collection and counting failed to enforce prescribed safeguards or ignored warning signs.

The report is likely to examine accountability at every stage of the donation management process — from the custody of donation boxes and transportation of cash to counting, banking, surveillance and auditing. The SIT is assessing whether SOPs were followed and whether lapses in supervision, documentation, access control, record

maintenance and internal checks created opportunities for the alleged diversion of devotees' offerings. Officials said the inquiry has also focused on identifying institutional weaknesses.

Sources said the SIT has studied best practices adopted by major religious institutions to prepare a set of recommendations aimed at making the Ram Temple's donation management system more secure and transparent.

PAC jawan electrocuted while checking power fault in Rudrapur

Rudrapur: A 36-year-old Provincial Armed Constabulary (PAC) jawan was electrocuted on Monday evening while attempting to inspect a suspected power fault near his residence in

Local residents and family members rushed him to nearby medical facility. Following initial treatment, doctors referred him to district hospital, where he was pronounced dead on arrival. A police team sent body for post-mortem. "The exact circumstances leading to the incident are currently under investigation," a police officer said.
