

BRIDGE

End-play or throw-in is an elegant play which forces a defender to open a suit at a time which will be detrimental to defenders and helpful to declarer. Obviously to effect an end-play, declarer should be able to have a card by which he can throw-in the defender of choice. It is easy to throw away the throw-in card, unless declarer is alert to the possibilities of a throw-in. Dealer: North Vulnerable: East/West

West leads the seven of spades to East's ace. East returns the four of spades to West's king. West continues with the spade ten. East discards the three of hearts. Plan the play. It was all a matter of throw-in at no trumps.

Counting the queen of spades, South has eight sure winners. The best play for the ninth trick is in the diamond suit; declarer should cash one of dummy's high diamonds (guarding against a singleton queen), lead to the closed hand with a club, and play a second diamond towards dummy. If West follows to the second diamond lead, South can make the contract by finessing into the East hand. When West shows out on the second diamond lead, South must change plans: go up with the remaining high diamond in dummy, cash, then endplay West by leading dummy's remaining spade. West can cash the rest of the spades, but then must give South the last two tricks by leading into the major heart tenace. To keep this endplay in sight, declarer must win dummy's queen of spades at trick three. Another problem on South play. Dealer: North Vulnerable: East/West

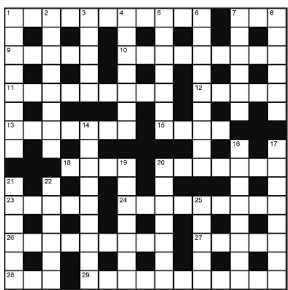
