A.P. CM to launch work on Rayalaseema steel plant today

In a major step towards industrialisation of the Rayalaseema region in Andhra Pradesh, Chief Minister N. Chandrababu Naidu will launch the construction works of the JSW Rayalaseema Integrated Steel Plant in Kadapa district on Friday. The commencement of construction transforms a long-pending aspiration into reality and reaffirms the State's commitment to make Rayalaseema a manufacturing and green industrial hub, says an official release.

Bengaluru ISRO headquarters evacuated after bomb threat

A hoax bomb threat was emailed to the Indian Space Research Organisation (ISRO) headquarters in Bengaluru, claiming explosives were planted at the high-security establishment. After a thorough security check by the police and bomb disposal squads, the email was declared a hoax. The email was received by the ISRO staff post-lunch. They alerted the police who rushed to the spot, and evacuated the campus. Police have launched a probe to trace the email sender.

Telangana DSP booked in disproportionate assets case

The Telangana Anti-Corruption Bureau (ACB) has registered a disproportionate assets case against Sankireddy Bheem Reddy, Deputy Superintendent of Police (DSP) posted at Police Computer Services (PCS), Hyderabad, alleging that he amassed assets disproportionate to his known sources of income through corrupt practices. The arrest came after ACB officials carried out simultaneous searches at the officer's residence and 15 other premises linked to him.

20 passengers held with fake visas at Hyderabad airport

The women passengers from A.P. were stopped from boarding an Oman Air flight after officials detected forged Kuwait visa documents; case filed against 39 accused, including 19 travel agents

Twenty women from East Godavari district of Andhra Pradesh were stopped from boarding an Oman Air flight at the Rajiv Gandhi International Airport in Hyderabad after immigration officials detected forged Kuwait visa documents that had been altered to bypass emigration requirements for overseas workers.

The police have registered a case against 39 accused – the 20 passengers and 19 travel agents – involved in arranging the forged documents.

According to the FIR, the women, all holders of Emigration Check Re-

quired (ECR) passports, were scheduled to travel to Kuwait via Oman, on Oman Air flight WY-236 during the intervening night of June 30 and July 1. During immigration clearance, officials noticed discrepancies in some of the visa documents and sub-

jected them to further verification. Officials verified the visas through the official Kuwait visa application and found that the passengers had originally been issued domestic worker visas. However, police said the visa documents had been al-

The HAL police have issued notice to five staff of the creche operating inside IT firm Capgemini in Bengaluru, summoning them for questioning about allegations of physical abuse and cruelty towards the children of the employees of the company.

The police registered an FIR against workers at the creche on June 29.

Police Commissioner Seemant Kumar Singh said that a special team, led by an officer of the rank of Deputy Commissioner of Police, was formed for the probe. "The FIR was registered based on a call to the child helpline..." he said.

The police have gathered video clips reportedly showing the alleged abuse and sent them to the Forensic Science Laboratory (FSL) for further verification.

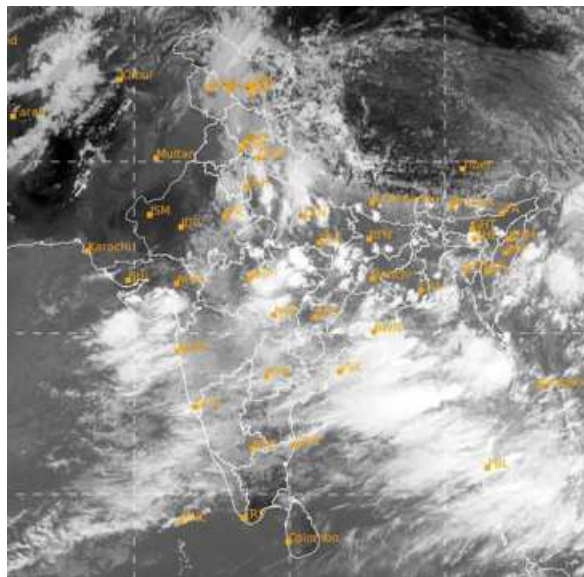
anticipatory bail plea moved by Mr. Khan had been dismissed by a Special Judge under the Protection of Children from Sexual Offences Act.
