Mr. Rahul Kumar Singh and Mrs. Surbhi Singh availed HL facility from Indian Bank, Circular Road Branch, the repayment of which is secured by Tripartite Agreement dated 01.01.2016 of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Rahul Kumar Singh and Mrs. Surbhi Singh failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated 20.08.2024.

As Mr. Rahul Kumar Singh and Mrs. Surbhi Singh failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **10.07.2026** after complying with all legal formalities.
