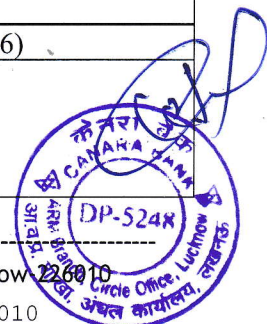

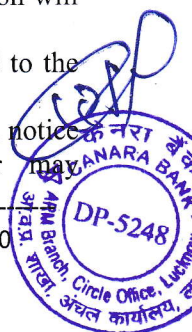

- f. Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplies of Rs.1,00,000/- for each property (Incremental amount/price) mentioned under the column "Increment Combo" (at least select 1). 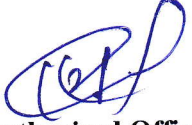
