FULFILLING the long-cherished dreams and aspirations of the people of North Andhra, the newly constructed ASR International Airport at Bhogapuram in Vizianagaram district will be inaugurated by the Prime Minister, Narendra Modi on August 1 in a grand manner.

Announcing the historic milestone, Director of Information and Public Relations (I&PR) KS Viswanathan stated that a week-long promotional campaign titled "Uttarandhra Kalalaku Rekkalu" (Wings to the Dreams of North Andhra) is being organised from Saturday.

Spearheaded by the I&PR Department in close coordination with district administration, the extensive events will span six districts-Vizianagaram, Srikakulam, Parvathipuram-Manyam, Alluri Sitarama Raju, Anakapalle, and Visakhapatnam-to highlight the airport's pivotal role in accelerating

ing holistic development, tourism, and industrial growth.

As part of the campaign, digital countdown screens have been installed at major public hubs across all district headquarters to stream the countdown live to the public.

To engage youth, quiz, painting, and essay-writing competitions centred on the theme "My District Takes Off" are being organised for students, with winners securing VIP seating at the main inaugural ceremony.

Special prayers and rituals will also be offered at prominent temples

across North Andhra for the smooth launch and future prosperity of the region. Highlighting the airport's impact on tribal empowerment, the Girijan Cooperative Corporation (GCC) is organising branding displays and exhibitions for local organic products like Araku Coffee and Araku Turmeric, with exclusive tribal produce set to be presented to the Prime Minister.

Public representatives and officials are conducting awareness seminars at key destinations to educate locals on expanding tourism prospects and home-stay registrations.

Additionally, SERP and MEP-MA will host a massive women's Rangoli competition on July 30 themed around the Bhogapuram airport project, alongside themed cricket and beach volleyball tournaments.

Folk performances and cultural shows will pay rich tribute to revolutionary hero Alluri Sitarama Raju at major centres and his birthplace, Pandrangi village.

Kharif-2024 crop insurance claims cleared

THE Centre has given its nod for the release of pending Kharif-2024 crop insurance claims after the Andhra Pradesh government assured that it would clear nearly ₹1,900 crore in outstanding crop insurance premium dues left unpaid during the previous YSRCP regime in a phased manner, Agriculture Minister Kinjarapu Atchannaaidu said on Saturday.

The minister said the assurance was conveyed to the Union government following his recent meeting with Union Agriculture Minister Shivraj Singh Chouhan, during which he explained the difficulties faced by farmers and outlined the State's plan to clear the pending premium liabilities.

He said the Centre had responded positively and agreed to release the insurance funds. Atchannaaidu stated that once the Centre releases the Kharif-2024 crop insurance amount, the eligible compensation will be credited directly into the bank accounts of farmers.

He said the coalition government was committed to safeguarding farmers' interests.

Will Lokesh resign now for DSC anomalies? Jagan

STATING that Union Education Minister Dharmendra Pradhan resigned from his post owning moral responsibility for the NEET paper leak, setting a benchmark for political accountability under the NDA Government, YSRCP President and former Chief Minister YS Jagan Mohan Reddy sought to know will Education Minister Nara Lokesh of the NDA Government in Andhra Pradesh

accept moral responsibility for the serious irregularities surrounding the DSC examination process (which involved around 3.5 lakh aspirants) and resign from his post? Or will Chief Minister N Chandrababu Naidu of the NDA Government shields his son instead of upholding the very standards of accountability that the NDA claims to believe in?

Taking to 'X' on Saturday, Jagan attached a letter written by the YSRCP to Prime Minister Naren-

dra Modi, and informed that the so-called 'Mega' DSC was a carefully engineered policy sketch for a scam of vast proportions, a dark operation by Chandrababu and his son Lokesh as Minister-in-charge, grievously damaging the lives of meritorious aspirants.

Lakhs of aspirants are in anguish today because of the manipulation and deception committed by the present State Government. The State never witnessed such a devious recruitment process before, he said.

For the recruitment process for 16,000 DSC posts, every safeguard that protected transparency was dismantled and every institutional check was weakened, the letter read.

Stating that the scandal is deeply rooted and dangerously conceived by the people at the helm of the present State Government including the Chief Minister and the Education Minister, Nara Lokesh, the YSRCP requested for an enquiry by an independent agency such as CBI.
