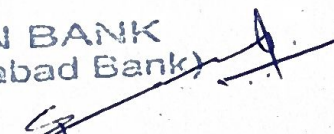

Smt Saneha Sinha & Mr. Amar Kumar Sinha availed Housing Loan facility from Indian Bank, Minapur Chowk Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Smt Saneha Sinha & Mr. Amar Kumar Sinha failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 15.07.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) Smt Saneha Sinha & Mr. Amar Kumar Sinha and its Guarantors are liable to the Bank to pay the amount due to the tune of **Rs.15,69,528/- (Rupees Fifteen Lac Sixty Nine Thousand Five Hundred Twenty Eight Only)** as on 15.07.2023 with further interest, costs, other charges and expenses thereon from 15.07.2023 till realization of bank's dues.. Both failed to make full payment despite Demand Notice dated 15.07.2023.

As Smt Saneha Sinha & Mr. Amar Kumar Sinha failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **08.11.2023** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 21.07.2026 Rs.21,21,663.00/-(Rupees Twenty One Lac Twenty One Thousand Six Hundred Sixty Three Only) with further interest, costs, other charges and expenses thereon from 21.07.2026.

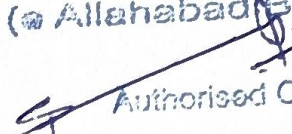
