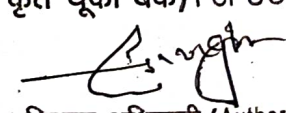


PUBLIC NOTICE OF E-AUCTION SALE (FOR IMMOVABLE PROPERTY)

- 2) Date & time of inspection of Property : 13.08.2026 – 10: 00 A.M to 5: 00 P.M
- 3) Date and time of auction: 14.08.2026 between 11:00 A.M. to 05:00 P.M. as per (IST)
- 4) Auction would be conducted for an initial period of 360 minutes followed by unlimited extensions of 10 minutes each, in case a valid bid is received in last 10 minutes.
- 5) Auction would commence at Reserve price, as mentioned above. Bidders shall improve their offers in multiples of **Rs. 50,000/- (Fifty Thousand only)**
- 6) Intending bidder shall register with the E-AUCTION portal to create their user-ids and passwords. Bidders have to register online by providing their KYC documents and registration fees as prescribed by the service provider (EBIKRAY). Once the KYC documents are verified by **BAANKNET**, the registration will be activated within a period of maximum two working days from the date of submission of all KYC documents and registration fees.

- 10) A copy of the Bid form along with the enclosure submitted online (also mentioning UTR Number) shall be handed over to the Authorized Officer, **UCO Bank**, at above mentioned address or soft copies of the same by E-mail to kurnoo@uco.bank.in
- 11) The successful bidder shall have to pay 25% of the purchase amount (including earnest money already paid through wallet), immediately on closure of the E- Auction Sale proceedings on the same day or next day of the Sale in the same mode as mentioned above and the balance 75% of the purchase price shall have to be paid within 15 days or within the extended time from the date of confirmation of sale by the authorized officer.
