**Sub : Your Loan Account Nos.7662932893, 7662891968 & 7662834397 of Mr. Abdul Rahaman and Mrs. Serajunnisha with Indian Bank, Selaiyur Branch.**

Mr. Abdul Rahaman and Mrs. Serajunnisha availed loan facilities from Indian Bank, Selaiyur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Abdul Rahaman and Mrs. Serajunnisha failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 10.09.2025 under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling Mr. Abdul Rahaman and Mrs. Serajunnisha liable to the Bank to pay the total amount due to the tune of Rs.2,17,49,860.29 (Rupees Two crores seventeen lakhs forty nine thousand eight hundred sixty and paise twenty nine only) as on 10.09.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 10.09.2025.

As Mr. Abdul Rahaman and Mrs. Serajunnisha failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 10.12.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.**

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The total amount due as on 26.07.2026 is Rs.2,39,15,190/- (Rupees Two crores thirty nine lakhs fifteen thousand one hundred and ninety only) with further interest, costs, other charges and expenses thereon from 27.07.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 14.08.2026 from 10.00 a.m. to 4.00 p.m. which would be by e-auction mode.
