**Sub: Loan account – M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd (A/c No- 6398274930/ 6887986623) with Indian Bank, Borivali West Branch.**

M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd availed MSME Loan facility from Indian Bank, Borivali West Branch, Mumbai the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt. Ltd failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 17.05.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) 1. M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd 2. Mr. Fenil Bhimani (Director & Guarantor) 3. Mrs. Mita Bhimani (Director & Guarantor) 4. Mr. Satish Rohidas Kale (Guarantor & Mortgagor) liable to the Bank to pay the amount due to the tune of Rs. 94,78,360/- (Rupees Ninety-Four Lakhs Seventy-Eight Thousand Three Hundred Sixty only) as on dated 28.02.2022 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 17.05.2022.



As 1. M/s HNO Furnishing Ltd. Earlier known as M/s Dev Blessings Textiles Pvt Ltd 2. Mr. Fenil Bhimani (Director & Guarantor) 3. Mrs. Mita Bhimani (Director & Guarantor) 4. Mr. Satish Rohidas Kale (Guarantor & Mortgagor) failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18.08.2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

**THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.**

\*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 10.07.2026 is Rs. 1,05,04,718- (Rupees One Crore Five Lakh Four Thousand Seven Hundred Eighteen Only) with further interest, costs, other charges and expenses thereon from 10.07.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

**The date of sale is fixed as 07.08.2026 which would be by e-auction mode.**
