

Homestay owner's arrest illegal, says HC

US CITIZEN'S RAPE

DECLARING the arrest of the owner of a homestay in Kodagu, where a 33-year old US citizen was allegedly raped by a housekeeper in April 2026, as illegal, the Karnataka High Court directed the state government to pay compensation of Rs 5 lakh to him for confining him in judicial custody illegally for 14 days.

“Merely because the US embassy or that of any other country would communicate a complaint to the investigating agencies, it would not mean that the fundamental rights of the citizens should be bartered away,”

said Justice M Nagaprasanna, pronouncing the order on Wednesday, while partly allowing the petition filed by 55-year-old owner of the home-stay challenging the legality of his arrest as well as the registration of the FIR.

The court, however, said that the award of this compensation shall not operate as a bar to the petitioner pursuing any additional claim for damages before a competent civil court in enforcement of a private law remedy. The present compensation is but a constitutional acknowl-

edgement of the wrong suffered, the court said.

Noting that the constitutional courts have consistently taken note of the suffering, indignity and humiliation inflicted upon citizens at the hands of the agents of the State, the court said that the arrest of the petitioner is held to be manifestly illegal and in blatant violation of the guidelines laid down by the Supreme Court.

Referring to the offences invoked in the case, the court noted that the foremost among them is, Section 64(1) of the

BNS, which deals with the offence of rape. Yet, the invocation of the said provision against the petitioner appears *prima facie*, wholly incongruous, for the petitioner was admittedly nowhere present at the scene of the alleged occurrence and is not attributed with any overt act constituting the offence. The remaining offences alleged are under Sections 228, 239 and 351 of the BNS, all of which are non-cognizable in nature. Notwithstanding the unmistakable character of these offences as non-cognizable, the petitioner was picked up by the police on

the evening of April 18, 2026, detained through the night, and formally arrested at 5 am on April 19. Thereafter, he was produced before the learned magistrate only at 11.30 pm on the following day for the purpose of remand.

However, the court refused to quash the FIR registered by Kutta police at this stage, reserving liberty to the petitioner to approach the court in the event he is aggrieved with the final report.

The court also stayed all further proceedings pending before the trial court in Ponnampet, till July 30, the next date of hearing.

UNDECLARED CASH

6 Hakki Pikki members detained at Fiji airport

SIX members of the Hakki Piki tribal community from Mysuru district have been stranded in Fiji after they were detained by customs authorities at the airport while attempting to return to India.

The group, all residents of Pakshirajapura village in Hunsur taluk, had travelled to the South Pacific island nation around four months ago on a tourist visa under a sponsorship arrangement to participate in exhibitions and sell herbal products, a traditional livelihood of the Hakkı Pikkı community.

Karnataka Hakki Pikki Tribes Association (KHPTA) president Puneeth Kumar R told TNIE that the six persons were stopped by customs officials at the Fiji airport while they were preparing to board a flight back to India. The officials reportedly questioned them over the possession of

sought proof that the amount had been declared to customs.

The detained persons have been identified as Manish, Krishna Kumar, Malini, Chandran Dasu, Sanjana Chandran and Harish Sampath.

Puneeth said the travellers had not submitted the required customs declaration while entering or carrying the cash, following which the authorities seized the money and initiated an inquiry. Customs officials are

also said to have questioned them about the source of the cash and their purpose of travel. "The six members have been stranded there since July 12. They are safe, but they are unable to return to India until the

issue is resolved. We request the Indian Embassy and the Ministry of External Affairs to intervene immediately and facilitate the safe return of our people," Puneeth said.

Puneeth said the incident once again brings to the fore the recurring difficulties faced by members of the Hakki Pikkis community, many of whom travel abroad to sell herbal medicines and traditional products. In recent years, several community members have reportedly faced detention, immigration issues and visa-related complications in different countries, particularly in parts of Africa.

He alleged that many tribal members become victims of fraudulent travel agents who arrange fake or incomplete travel documentation, leaving them vulnerable to legal action in foreign countries. In some cases, they have had to pay fines of up to USD 40,000 or remain stranded for extended periods before

Stating that such incidents have become increasingly common, Puneeth called upon the Ministry of External Affairs to evolve a permanent mechanism to support members of the Hakkli Pikki tribe travelling overseas.

He also urged the government to create an awareness programme on international customs and immigration regulations, verify travel documentation before departure, monitor agents arranging overseas travel and establish faster coordination between Indian embassies and local authorities so that community members are not left helpless in foreign countries.

Temp rise will continue for 7 days, says IMD

BENGALURU: India Meteorological Department (IMD) has said the entire state is recording a rise in maximum temperatures by 2–3 degrees Celsius. In the absence of cloud cover and rain, the IMD has forecast a rise in maximum temperatures by 3–5 degrees Celsius for most parts of the state. According to IMD data, Bengaluru on Tuesday recorded a maximum of 33.6 degrees Celsius, which was the highest in July. The highest so far recorded was 33.1 degrees Celsius on July 1, 1914 and 1926. On July 1, 2021 the City had recorded 32.7 Degree Celsius. On Wednesday, Bengaluru recorded a maximum of 32.2 degrees Celsius, against the normal maximum temperature of 28.3 degrees Celsius (3.9 Degree Celsius above normal). Kempegowda and HAL airports observatories recorded 33.1 Degree Celsius, respectively. As per IMD data, Koppal and Raichur had recorded the maximum temperature of 38.8 and 36 degrees Celsius, respectively, on Wednesday. Kalaburgi recorded 36.1 degrees Celsius and Bidar 36.6 degrees Celsius. **ENS**

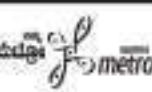
