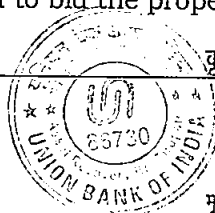
10. 2. KYC Verification

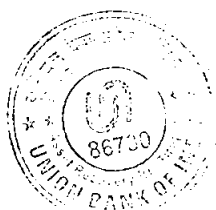

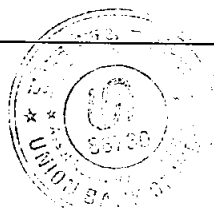

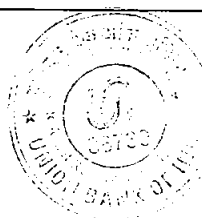
