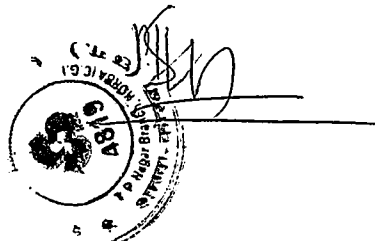

Therefore a Demand Notice dated 01.10.20125 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon **M/s Mukund Auto**, Prop: Mr Mukund Awasthi,Behind Type C Qtr, Sector 6 ,Indira Market, Balco Nagar, Korba, Pin 495684 , Mr Mukund Awasthi ,S/o- Arun Kumar Awasthi ,Behind Type C Qtr, Sector 6 ,Indira Market, Balco Nagar, Korba, Pin 495684 and Mr Arun Kumar Awasthi S/o- P P Awasthi ,Behind Type C Qtr, Sector 6 ,Indira Market, Balco Nagar, Korba, Pin 495684 liable to the Bank to pay the amount due to the tune of **Rs. 2404692.00 (Rupees Twenty four lakh four thousand six hundred and ninety two only** with further interest, costs, other charges and expenses thereon. They failed to make payment despite Demand Notice dated 01.10.2025.

As M/s Mukund Auto failed to make payment despite Demand Notice, the Authorized Officer took Symbolic possession of the schedule mentioned properties under the Act on 21.02.2026 after complying with all legal formalities.

As per Rule 6 (2) and 8(6) / 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

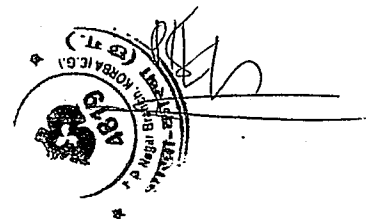

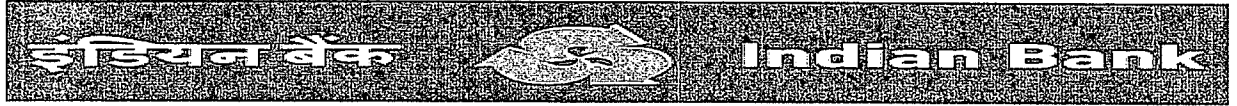
