

SOG's investigation into Sidsar Madrasa case intensifies

Bhavnagar, A thorough investigation has been conducted by SOG and special agencies in the case of an illegal madrasa caught during a mega combing four days ago in 25 Wariya area of ??Sidsar near Bhavnagar. Maulana Mohammad Sharif, who was arrested with provocative and objectionable literature, is currently under 10-day police remand. Keeping in mind the suspicious role of Maulana, the country's Central Intelligence Agencies have also started intensive interrogation of him. Along with this, the SOG team has reached Bharuch along with Maulana.

Madrasa was running in Gujarat Housing Board buildings. During the police investigation, it was revealed that an illegal madrasa was being run in Gujarat Housing Board buildings number 110, 111 and 112 located at Sidsar 25 Waria by changing the purpose. During the investigation, objectionable literature including 15 books written in Urdu and Arabic as well as a 60-page diary written by the cleric himself were found in the possession of 26-year-old Maulvi Mohammad Sharif Abbasbhai Maredia (native of Badargarh, Ta. Palanpur, G. Banaskantha). When it was revealed that

poison was being poured into the minds of children through this literature, a case was registered at Vartej police station and the Maulana was arrested. All this literature will be sent to the FSL for further investigation. SOG team reaches Bharuch after Bharuch connection comes to light. According to information received from police sources, before coming to Bhavnagar, the Maulana, originally from Banaskantha, used to study in Bharuch. Since he was brought to Bhavnagar from Bharuch, a special team of Bhavnagar SOG has reached Bharuch for investigation along with Maulana to find out where his connections are. First round of admission process for PG Engineering announced

Ahmedabad, The 'Admission Committee for Professional Courses' (ACPC), operating under the Technical Education Department of the state government, has announced the first round of seat allotment for admission to postgraduate engineering (PG Engineering) courses. Under this round, a total of 1317 students have been offered seats in government, aided and self-financed institutions across the state. A total of 5244 seats are available in various engineering colleges of the state, out of which the admission process was conducted for 4312 seats held by ACPC. A total of 1935 students registered for these seats. This includes 154 candidates with GATE qualification and 1781 candidates without GATE. It is worth mentioning that the PG CET-2026 examination was held on June 27 and 28 for candidates other than GATE.

Five and a half inches of rain in Kaprada in 24 hours

Orange alert in 7 districts today, yellow alert in 11 including Ahmedabad; 42 thousand people evacuated due to heavy rain

Ahmedabad In the last 24 hours, the highest rainfall of 5.51 inches has been recorded in Kaprada of Valsad among 204 talukas. So, 3.86 inches have been recorded in Ogad, 3.39 inches in Khergam, 3.31 inches in Nadiad, 3.11 inches in Nanapondha and more than 2 inches in 13 other talukas. Today, Sunday, from 6 to 8 am, 28 talukas have received rainfall ranging from 1 mm to 1 inch. Heavy to very heavy rainfall has been predicted in Gujarat, especially in North Gujarat, in the next 24 hours amid widespread cloud cover, following which Chief Minister Bhupendra Patel held a review meeting with top officials at the 'State Emergency Operation Center' (SEOC) late in the evening yesterday. NDRF and SDRF teams have been deployed in Patan, Mehsana, Vav-Tharad and Banaskantha in view of the possibility of

more rain, while 42,158 people have been evacuated to safer places from across the state so far. On the other hand, as the intensity of rains in South Gujarat has decreased, the administration has focused on cash donations and relief operations. Heavy rains cause havoc in Charanka Solar Power Plant Asia's largest solar power plant located at Charanka in Santalpur taluka of Patan district has suffered major damage due to waterlogging due to heavy rains. Electrical equipment like inverters, transformers and control rooms of 36 companies including ReNew Power, Aditya Birla, Mahindra Tego, GNFC and GPCL operating in the plant have been submerged, affecting power generation. A detailed survey will be conducted after the water recedes, but it is feared that crores of rupees have been lost on an initial basis.

Ahmedabad computer engineer dies on the spot in car accident in Canada

Ahmedabad, A 22-year-old computer engineer from Ahmedabad died in a car accident in Canada on the night of July 18. A speeding



car driver on the wrong side of the Saskatchewan Highway in Canada hit Bhishma Rajyaguru's car hard at night. Due to which Bhishma's car overturned in a nearby field and he died due to serious injuries.

Bhishma's body will be brought to Ahmedabad on August 2. According to Canadian media reports, the car of the accident victim, Jaden Daleks, captain of the Russ Riding Game, was on the wrong side of the road and alcohol and drugs were found in it. Bhishma was working in a car leadership company. According to the information received, 22-year-old Bhishma Rajyaguru, a resident of Yashkunj Society in Ghatlodia area of ??Ahmedabad, had been living in Regina, Canada for the last 4 years. After studying up to Std. 12 in Ahmedabad, Bhishma had gone to Canada to study computer science and had been working in a car leadership company for the last one year.

Bhishma was returning home from work when a speeding car in the opposite lane hit Bhishma's car at around 9 pm on Saskatchewan Highway No. 11. The impact was so strong that Bhishma's car bounced and overturned in a nearby field. The accident caused a heavy traffic jam on the highway. Videos of the incident have also surfaced. Bhishma died on the spot due to internal bleeding. Bhishma was seriously injured in a car accident. He died on the spot due to internal bleeding. After the accident, Bhishma's friends and people from the Gujarat community came to know about it and immediately reached the spot. The driver of the car that hit Bhishma's car was Jaden Daleks, captain of the Ras Riding Game. Action has been taken against the driver who caused the accident.

Regina's local mayor posted a tribute. A few days after Bhishma's accident, his body was postmortem. The local mayor also posted a tribute regarding Bhishma's death. Apart from this, Bhishma was also paid tribute on the big screen during the Rough Riders match. Bhishma's family consists of father Ashishbhai Rajyaguru, mother Purviben Rajyaguru and a younger sister Hir Rajyaguru. Bhishma's mortal remains will be brought to Ahmedabad on August 2.

Two rescue operations in Vadodara

Elderly man falls from first floor into rain gutter in Nizampura, youth gets trapped in lift in Vasana-Bhayali; gets out by breaking door

Vadodara Two rescue operations were carried out in Vadodara city on Sunday evening after the fire department received two separate emergency calls. In one incident, an elderly man was injured after falling from the first floor, while in the other incident, a young man got scared after getting trapped in a lift. In both the incidents, no casualties were reported as the fire department team rescued him.

Old man fell from the first floor to the edge of a rain gutter. In the first incident, an old man, Harisinh Madhuka, living in Nizampura Sardar Nagar area of ??the city, fell from the first floor. He fell to the edge of a rain gutter passing by. As soon as the incident was reported, the Wadiwadi Fire Brigade team immediately reached and rescued him and brought him to the first floor. After that, he was shifted to a private hospital in Fatehganj area by ambulance for treatment. Fortunately, no one was injured in this incident.

A young man was trapped in a lift for 25 minutes in Vasna-Bhayli. The second incident took place in the Aristo Complex opposite Priya Talkies in Vasna-Bhayli area. Bhavik Vaghela, who was working in an office on the third floor, was coming down when the lift suddenly stopped on the second floor. He remained trapped in the lift for 25 minutes. During this, he called the fire department. The fire department broke the door and pulled out the vessel.
