TERMS AND CONDITIONS OF E-AUCTION SALE

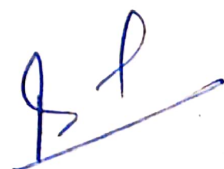
- The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 the following further conditions.
The auction sale will be "online through e-auction" portal <https://baanknet.com>
- The intending Bidders/ Purchasers are requested to register on portal (<https://baanknet.com>) using their email mobile number. The process of eKYC is to be done through Digilocker. Once the e-KYC is done, the intending Bidders/ Purchasers may transfer the EMD amount to their e-Wallet using online/challan mode before the e-Auction Date as in the portal. The registration, verification of e-KYC, transfer of EMD in wallet and linking of wallet amount to Property be completed well in advance, before auction.
- Earnest Money Deposit (EMD) amount as mentioned above shall be paid online/challan mode and will be credited in e-Wallet. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Money Deposited shall not bear any interest.
