Daman MP Umesh Patel and ex-panchayat chief convicted in 2012 case



The court of Chief Judicial Magistrate P P Bharsakhade-Wagh sentenced the MP and the former panchayat president to two years' simple imprisonment and gave them a month's time to appeal in a higher court.

Umesh Patel, 48, won the Daman seat defeating the three-term BJP MP Lalu Patel in the 2024 Lok Sabha general elections as an Independent candidate. The case dates back to March 12, 2012, when interviews were on for the post of assistant sub-inspector for the excise department, at the Sports Club football ground in Daman.

The two were accused of entering the room where a candidate's interview was underway and making "false allegations".

Jagmahendra Singh, the then Assistant Superintendent of Police posted at Damian police headquarters, filed a complaint against Umesh Patel, who was the then president of the NGO Youth Action Force, and Suresh alias Sukha Patel, accusing them of threatening the police personnel present at the main entry gate and forcibly entering the football ground. "They entered the room where the candidates' interview was in progress and made false accusations against the committee interviewing them," the FIR had said.
