Ludhiana: A former SHO in the city has been removed from his post and sent to the police lines after being accused of raping a woman inspector. Ludhiana SSP-rural Ankur Gupta said the FIR against sub-inspector Sahibmeet Singh was registered on Thursday and that he had been shifted to the lines from Sudhar police station two-three days earlier. The FIR alleges that the SI mixed an intoxicating substance in her soft drink and raped her after she fell unconscious. According to the complaint, when she confronted the accused after the rape, he promised to marry her but then broke off all contact with her. **TNN**

Ajnala thana attack: Accused held while crossing into India

Pilibhit: A wanted accused in the 2023 Ajnala police station attack in Punjab was arrested by a joint team of Bahraich police, the Sasasra Seema Bal (SSB) and the Uttar Pradesh Anti-Terrorism Squad (ATS) while allegedly trying to enter India from Nepal through the Rupaidiha checkpoint in Bahraich on Thursday evening. The Ajnala police station attack took place on Feb 23, 2023, when radical preacher Amritpal Singh and hundreds of his armed supporters stormed the police station, injuring six police personnel to secure the release of his arrested aide, Lovepreet Singh Toofan. Bahraich SP Vishwajeet Shrivastav told TOI that the accused, identified as Vikramjeet, 45, came under suspicion after producing an Aadhaar card at the border

checkpoint as proof of identity. During online verification, police allegedly found the Aadhaar card to be fraudulent.

Asked why Vikramjeet was trying to enter India, Shrivastav said the accused told police that his lawyer had called him to Punjab in connection with one of his court cases. He allegedly be-

lieved the matter would be resolved through an amicable settlement arranged by his associate, Joga Singh.

During questioning, Vikramjeet allegedly told investigators that he had fled to Kathmandu after the Ajnala police station attack and remained in hiding there. He claimed Joga Singh, a granthi (preacher)

at Mohanpur gurdwara in Purnapur tehsil of Pilibhit district, had arranged his accommodation, transport and other logistical support in Nepal.

Acting on the information, Bahraich police and the ATS arrested Joga Singh from the gurdwara late on Thursday night. Investigators alleged that he had also arranged a car for Amritpal Singh and sheltered him at a gurdwara during his visit to Pilibhit in March 2023 before his onward journey to Amritsar. Joga Singh was arrested by Punjab police in April 2023 but was later released.

Shrivastav said police had also arrested three Bahraich residents for allegedly providing logistical support to Vikramjeet. Vikramjeet is being questioned by the ATS and Punjab police. No FIR had been filed till the time of this report.

Singing state song once a week must in assemblies at Haryana govt schools

Gurgaon: Govt school students across Haryana have been asked to sing the official state song during morning assemblies once a week. A circular from directorate of school education issued on July 22 asks schools to ensure 'Jai Jai Haryana' is sung immediately after the morning prayer. The National Anthem will continue to include the assembly.

Officials said the initiative is intended to instil pride and belongingness among students and ensure they feel equally connected to their roots.

"Children in several private institutions grow up with school anthems. This is to ensure those in govt schools across Haryana never feel left behind," an official said.

The official added that the weekly rendition was expect-

ed to nurture a sense of cultural pride while familiarising students with the state's history, geography, traditions, and values.

The 21-line song, written by Balakrishna Sharma, was unanimously adopted by the state assembly on March 28 last year. It celebrates Shiv-ali Hills as Haryana's crown, Aravali Range as its foundation, and Yamuna and Saraswati as symbols of its spiritual legacy.

The lyrics describe Haryana as the land of Vedas, the birthplace of Bhagavad Gita's message and the setting of Mahabharata, while highlighting the religious harmony in the celebration of Holi, Diwali, Eid, Gurpurab and Teej. The song hails the simple lifestyle centred around milk and curd prevalent in the state, and salutes its hard-working farmers, brave soldiers guarding the borders, and athletes bringing glory to the nation.
