Mrs. Arpita Sarker (Borrower & Mortgagor in the HBL A/C of Mrs. Arpita Sarker)availed Cash Credit/HBL/ Term Loan facilities from Indian Bank, Roynagar Bansdrone Branch , the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties", Mrs. Arpita Sarker failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 09.10.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Mortgagor , Guarantor(s) of Mrs. Arpita Sarker to pay the amount due to the tune Rs. 3051125.84 (Rupees Thirty Lacs Fifty One Thousand One Hundred Twenty Five and Paise Eighty Four only) as on 09.10.2025 and with further interest, costs, other charges and expenses thereon till realization of dues. Both failed to make payment despite Demand Notice dated 09.10.2025

As Mrs. Arpita Sarker failed to make payment despite Demand Notice, the Authorised Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities on followed by physical possession taken on 29.01.2026.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, undersigned / Authorized Officer intends selling the schedule mentioned securities.

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2), Rule 8(6) and Rule 9 (1) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice. The amount due is **Rs. 3051125.84 (Rupees Thirty Lacs Fifty One Thousand One Hundred Twenty Five and Paise Eighty Four only)** as on **09.10.2025** with further interest, costs, other charges & expenses thereon due to the Indian Bank.

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15 days**.

The date of sale is fixed as 17.08.2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
