Mr. Sachin Bharat Dubey availed Housing Loan facility from Indian Bank, JOGESHWARI WEST Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Sachin Bharat Dubey** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 29.05.2023 Under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **Mr. Sachin Bharat Dubey** liable to the Bank to pay the amount due to the tune of Rs. 15,89,347.00 (Rupees Fifteen Lakh Eighty Nine Thousand Three Hundred And Forty Seven only) as on 29.05.2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 29.05.2023

As **Mr. Sachin Bharat Dubey** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 25.08.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended sale is required to be given and hence we are issuing this notice.
