Mr. ASHOK KUMAR RAMCHABILA SINGH and Mrs. REKHA ASHOK SINGH availed Housing Loan facility from Indian Bank, BANDRA EAST Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. ASHOK KUMAR RAMCHABILA SINGH and Mrs. REKHA ASHOK SINGH failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 31.08.2019 Under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), ~~Guarantor(s)~~ Mr. ASHOK KUMAR RAMCHABILA SINGH and Mrs. REKHA ASHOK SINGH liable to the Bank to pay the amount due to the tune of Rs. 19,14,410.00 (Rupees Nineteen lakh fourteen Thousand four hundred and ten only) as on 29.08.2019 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 31.08.2019

As Mr. ASHOK KUMAR RAMCHABILA SINGH and Mrs. REKHA ASHOK SINGH failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 11.12.2019 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **29.08.2019, Rs. 19, 14,410.00 (Rupees Nineteen Lakh Fourteen Thousand Four Hundred And Ten Only)** with further interest, costs, other charges and expenses thereon from **29.08.2019**.

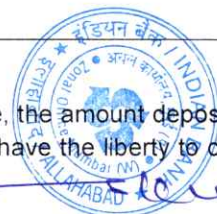

Ltd.) **for depositing in bidders EMD Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefore.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer.
