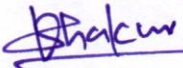

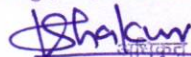
- h) EMD deposited by the unsuccessful bidder shall be refunded from **E-Wallet of M/s PSB Alliance Private Limited (E-bkray) portal**. The EMD shall not carry any interest.
- i) Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplies of **Rs. 5,000**. The bidder who submits the highest bid (not below the Reserve price) on closure of 'Online' auction shall be declared as successful bidder.
