1. Union Bank of India, SAM Branch, Lucknow, the secured creditor, caused a demand notice dated 15.07.2025 of Security Interest Act 2002, calling upon you to pay the dues within the time stipulated therein. Since you failed to comply with the said notice within the period stipulated, the Authorized Officer, has taken Symbolic possession of the immovable secured assets under Section 13(4) of the Act read with Rule 8 of Security Interest (Enforcement) Rules, 2002. Possession notice dated 23.09.2025 issued by the Authorized Officer, as per Appendix IV to the Security Interest (Enforcement) Rules, 2002 was delivered to you and the same was also affixed to the properties mortgaged with the Secured Creditor, apart from publication of the same in newspapers. Please note that as per the said demand notice you were informed about your right to redeem the property within the time available under Section 13(8) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002.
2. As you have failed to clear the dues of the secured creditor, the immovable secured assets that have been taken possession by the Authorized Officer, will be sold by holding public E-auction on 11.08.2026 (Tuesday) from 12:00 Noon to 05:00 p.m. by inviting Bids from the public through online mode on <https://baanknet.com>.
3. The reserve price will be for property Rs.21,50,000.00 Lac (Rupees Twenty-One Lac & Fifty Thousand only).

As per provision of Section 194-IA of Income Tax Act, 1961, TDS @ 1 % will be applicable on the sale proceeds or stamp duty value of such property, whichever is higher, where either sale proceeds or stamp duty value is Rs. 50,00,000/-(Rupees fifty lakhs) and above.
