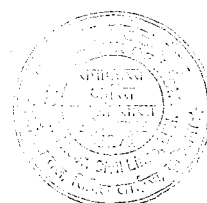

The successful bidder shall be required to submit the final prices, quoted during the eauction as per the annexure after the completion of the auction, duly signed and stamped as token of acceptance without any new condition other than those already agreed to before start of auction.</p> <p>(e).
