M/s Kota Institute of Education availed Cash Credit & Term Loan facility from from Indian Bank, Apcar Garden Branch, Asansol (e-Allahabad Bank), and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Kota Institute of Education failed to pay the outstanding dues to the Bank.
