3. 8. The successful Auction Purchaser / Bidder shall have to deposit 25% (Twenty Five Percent) of the bid amount (i.e. including EMD amount deposited earlier) immediately on finalization/concluding of Auction i.e. on the same day or not later than next working day. 11. On receipt of the entire sale consideration, the Authorized Officer shall issue the Sale Certificate as per Rules.
