NOTICE OF SALE

Notice of sale under Rule 6(2) & 8(6) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Shri Tapas Dutta availed Cash Credit/HBL Term Loan facilities from Indian Bank, Naktala Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties", Shri Tapas Dutta failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 27.04.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Mortgagor, Guarantor(s) of Shri Tapas Dutta (Borrower/ mortgagor) to pay the amount due to the tune of Rs. 3935493.00 (Rupees Thirty Nine Lakhs Thirty Five Thousand Four Hundred and Ninety Three Only) as on 27.04.2023 and with further interest, costs, other charges and expenses thereon till realization of dues. Both failed to make payment despite Demand Notice dated 27.04.2023.

As Shri Tapas Dutta (Borrower mortgagor) failed to make payment despite Demand Notice, the Authorised Officer took possession of the schedule mentioned properties under the Act on 05.08.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2), Rule 8(6) and Rule 9 (1) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice. The amount due is Rs. 3935493.00 (Rupees Thirty Nine Lakhs Thirty Five Thousand Four Hundred and Ninety Three Only) as on 27.04.2023 and with further interest, charges & expenses thereon till realization of dues to the Indian Bank.

The date of sale is fixed as **05.08.2026** which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
