b. The property/ies will be sold above the Reserve Price.

The intending bidders shall deposit Earnest Money Deposit (EMD) of Rs. 13,36,000/- (Rupees Thirteen Lakh Thirty Six Thousand Only). being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" and provide following details on or before 5.00 p.m. of 10-09-2026.

f. Auction would commence at Reserve Price, as mentioned above.
