4. The e-tenders for these zones can be submitted online through the official website of the department i.e. www.haryanatax.gov.in. The remaining terms and conditions of e-tenders and allotment of zones shall be same, as informed vide the Public Notice, published in leading newspapers on 21st May, 2025, for inviting e-tenders for allotment of retail liquor zones of all districts in the State of Haryana. 6. The re-allotment of these zones shall be done at the risk and cost of original allottee. The original allottee shall be liable to make up any deficiency incurred by the State as a result of the re-allotment of these zones.

7. The allotment and grant of licence shall be subject to the provisions of the Haryana Excise Act, 1914, the rules framed thereunder, orders/instructions issued by the competent authority and the Excise Policy for the year 2025-27. Any clarification regarding the procedure may be obtained from the office of DETCs (Excise) in any of the districts.
