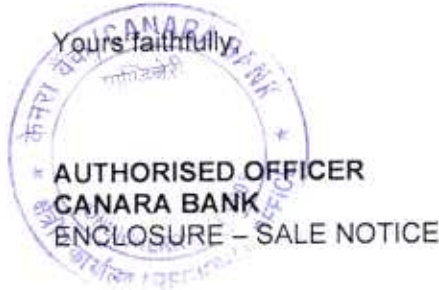

- f. Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiples of Rs.10, 000/- mentioned under the column "Increment Combo" (at least select 1).
