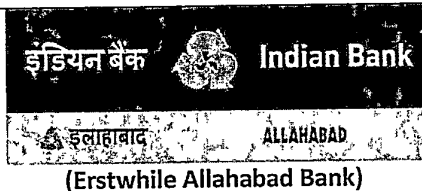

Mrs. Sulekha Banerjee and Ms. Dona Banerjee ( Home loan 7173847222 ) availed HBL facilities from Indian Bank, Kalyani Industrial Estate Branch, Dist NADIA, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. Sulekha Banerjee and Ms. Dona Banerjee ( Home loan 7173847222 ) failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 29.05.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling Smt. Sulekha Banerjee (Borrower cum Mortgagor) W/O Late Debasis Banerjee and Smt. Dona Banerjee (Borrower & Mortgager) D/O Late Debasis Banerjee liable to the Bank to pay the amount due to the tune of as Rs. 17,79,562.00/- (Rupees Seventeen Lakh Seventy-Nine Thousand Five Hundred Sixty-Two only) as on 29.05.2025 with further interest, costs, other charges and expenses thereon. All of them failed to make payment despite Demand Notice dated 29.05.2025.

As all of them failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 10.09.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

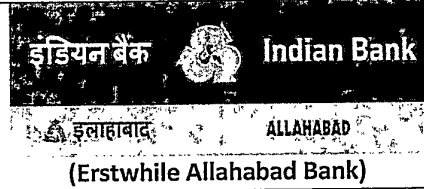

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 27.08.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from 21.07.2026 to 26.08.2026 between 10.00 am to 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule. The tender form and the terms and conditions would be available in the website from 21.07.2026 to 26.08.2026 from 10.00 am to 7.00 pm.

Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/ Purchasers have to transfer the EMD amount in his Global EMD Wallet by 26.08.2026 i.e. before the e-Auction time in the portal. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.

Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://baanknet.com>) for depositing in bidders Global EMD Wallet. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as Cheques will not be accepted. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/ cancel the sale without assigning any reason therefore.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of auction in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer. 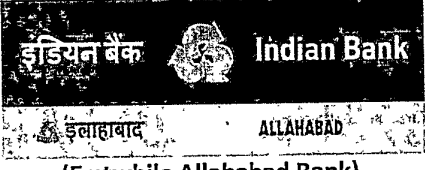
The sale is subject to confirmation by the Secured Creditor.
