M/S New Gold Brick Field Prop Sh. Israr Ahmad S/o Sh. Aziz Ahmad (Borrower) availed OCC/TL Limit facility from Indian Bank (Erstwhile Allahabad Bank), Branch: Railwayganj Hardoi, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Sh. Israr Ahmad S/o Sh. Aziz Ahmad (Borrower) failed to pay the outstanding dues to the Bank. As 1) M/S New Gold Brick Field Prop Sh. Israr Ahmad S/o Sh. Aziz Ahmad (Borrower), 2) Sh. Israr Ahmad S/o Sh. Aziz Ahmad (Borrower/Mortgagor/ Guarantor) failed to make payment despite Demand Notice, the Authorized Officer took Possession of the schedule mentioned properties under the Act on 20.06.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
