A/c – Mr MOHAMMED JAMIL availed Home loan facility from Indian Bank, Jagatsinghpur Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Property".

Mr MOHAMMED JAMIL failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 21.02.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon

liable to the Bank to pay the amount due to the tune of **Rs.14,75,653/- (Rupees Fourteen Lakhs Seventy Five Thousand Six Hundred Fifty Three only)** as on **20.02.2026** and **further interest @ applicable rates till the date of realization and costs, charges and expenses** thereon. All of you have failed to make payment despite Demand Notice dated **21.02.2026**

As **the borrower** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **12.05.2026** (symbolic possession) after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:



THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **30 days'** notice of intended sale is required to be given and hence we are issuing this notice.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, **30 days notice** for first time sale is required to be given and hence we are issuing the notice.

The amount due is of **Rs.14, 75,653/- (Rupees Fourteen Lakhs Seventy Five Thousand Six Hundred Fifty Three only)** as on **20.02.2026** and further interest @ applicable rates till the date of realization and costs, charges and expenses thereon.

Please take note that this is notice of **30*** days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **30 ***days.

The date of sale is fixed as **27.08.2026** which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **20.08.2006** to **26.08.2026** between **10.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
