Mr. RAJESH YASHWANT SALVI availed Term Loan facility from Indian Bank, Dombiveli East the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. RAJESH YASHWANT SALVI failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 09.01.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) Mr. RAJESH YASHWANT SALVI liable to the Bank to pay the amount due to the tune of Rs. 1984118.00/- (Rupees Ninteen lakh eighty-four thousand one hundred eighteen Only) as per demand notice dated 09.01.2023 with total amount of Rs. 3856289.00 (Ruppees Thirty-eight Lakh fifty-six thousand two hundred eighty nine Only) with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 09.01.2023

As Mr. RAJESH YASHWANT SALVI failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act on 26.04.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 10.08.2026 is Rs. 3856289.00 (Rupees Thirty-eight Lakh fifty-six thousand two hundred eighty nine Only) with further interest, costs, other charges and expenses thereon from 11.08.2026
