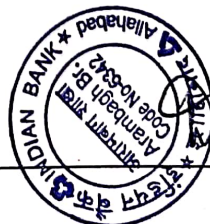

Mr. Sushanta Ghosh availed OCC and Term Loan facility from Indian Bank, Arambagh Branch, the repayment of which is secured by Mortgage and Hypothecation of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Sushanta Ghosh, Mrs. Barnali Ghosh, Mr. Sashanka Ghosh & Betbani Rice Mill Pvt. Ltd.** failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 04.03.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), **Mr. Sushanta Ghosh, Mrs. Barnali Ghosh, Mr. Sashanka Ghosh & Betbani Rice Mill Pvt. Ltd.**, liable to the Bank to pay the amount due to the tune of **Rs.1,09,24,891.00 (Rupees One Crore Nine Lakhs Twenty Four Thousand Eight Hundred Ninety One only)** as on **04/03/2026** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 04.03.2026.



As **Mr. Sushanta Ghosh , Mrs. Barnali Ghosh , Mr. Sashanka Ghosh & Betbani Rice Mill Pvt. Ltd.** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 06.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **04.03.2026** is **Rs.1,09,24,891.00 (Rupees One Crore Nine Lakhs Twenty Four Thousand Eight Hundred Ninety One only)** with further interest, costs, other charges and expenses thereon till the date of payment.

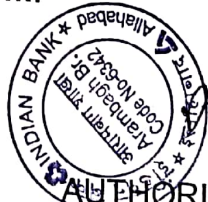
