Once the eKYC is done, The intending bidders/purchasers may transfer the EMD amount to their e-Wallet using online payment or challan mode. The EMD amount has to be linked with property before the EMD End date and time in the portal. The registration, verification of eKYC ,transfer of EMD in wallet and linking of wallet amount to property must be completed well in advance , before EMD End date and time/auction.
