M/s T J Agencies, Mr.Thomas P and Mrs.Radha Thomas availed secured OD and IND GECLS (6047306384 and 6888736263) facility from Indian Bank,Ettumanoor Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s T J Agencies, Mr.Thomas P and Mrs.Radha Thomas failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 20/07/2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s),M/s T J Agencies, Mr.Thomas P and Mrs.Radha Thomas are liable to the Bank to pay the amount due to the tune of Rs 16,15,610.97 (Rs.sixteen lakhs fifteen thousand six hundred and ten and ninety seven paisa only)as on **15/07/2022** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 20/07/2022

As M/s T J Agencies, Mr.Thomas P and Mrs.Radha Thomas failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 18/10/2022 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 05/08/2026 is Rs.36,99,440/- (Rupees Thirty six lakhs ninety nine thousand four hundred and forty rupees only) with further interest, costs, other charges and expenses thereon from 06/08/2026

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27/08/2026 which would be by e-auction mode.
