Mr. Binu J Kaimal on behalf of his proprietorship firm availed a Secured Overdraft loan facility from Indian Bank, Thodupuzha Branch, the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties" and personal guarantee of Mrs. Bindhu Mohanan and Mrs. Lakshmi Kunjamma being the mortgagors to the loan. Mr. Binu J Kaimal, proprietor of M/s Guruprabha Constructions failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 02.05.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon M/s Guruprabha Constructions, Proprietor Mr. Binu J Kaimal liable to the Bank to pay the amount due to the tune of Rs. 20,48,504/- (Rupees Twenty Lakh Fourty eight Thousand five Hundred and Four Rupees Only) as on 30.04.2025 with further interest, costs, other charges and expenses thereon. M/s Guruprabha Constructions, Proprietor Mr. Binu J Kaimal failed to make payment despite Demand Notice dated 02.05.2025.



As M/s Guruprabha Constructions, Proprietor Mr. Binu J Kaimal failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 01.08.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

The amount due as on 06/08/2026 is **Rs 21,64,979/-(Rupees Twenty One Lakhs Sixty Four Thousand Nine Hundred and Seventy Nine Only)** with further interest, costs, other charges and expenses thereon from 07/08/2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.08.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **10/08/2026 to 26/08/2026** between **10.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
