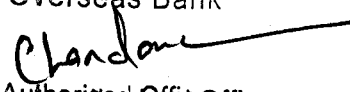

2. The intending Bidders /Purchasers are requested to register on <https://baanknet.com/> .using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. 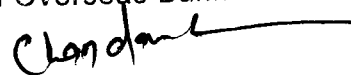

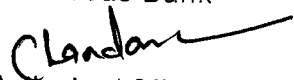
