Jayshree Vijay Mankar (Borrower/Mortgagor) AND OTHERS availed Home loan facility from Indian Bank, Nanapeth Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Jayshree Vijay Mankar (Borrower/Mortgagor) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 14.08.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Jayshree Vijay Mankar (Borrower/Mortgagor) AND OTHERS and others liable to the Bank to pay the amount due to the tune of Rs. 54,96,752/- as on 14.08.2024 with further interest, costs, other charges and expenses thereon both failed to make payment despite Demand Notice dated 14.08.2024.

As BHARAT SAHEBRAO DHAMALE (Borrower & Mortgagor) AND OTHERS and others failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 06.01.2025 and physical possession taken on 17.03.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **01.08.2026** is **Rs.65,48,490/-(Rupees Sixty Five Lakhs Forty Eight Thousand Four Hundred Ninety Only)** with further interest, costs, other charges and expenses thereon from **02.08.2026**.
