Shri. Neelesh Rajendra Abhonkar and Smt.Lalika Bhima Walke/Mrs. Latika Neelesh Abhonkar availed Home loan facility from Indian Bank, of Pune Cantanment Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Neelesh Rajendra Abhonkar and Smt.Lalika Bhima Walke/Mrs. Latika Neelesh Abhonkar** failed to pay the outstanding dues to the Bank.
