1. The Sale will be done through e-auction platform provided at the Website [https:// baanknet.com](https://baanknet.com) on 14.08.2026 (12:00PM to 5:00PM), E-auction agency contact details are:

It is advisable for Bidders to complete the following formalities well in advance.

Step 1: Bidder/Purchaser registration: Bidder to register on e-Auction Platform [https:// baanknet.com](https://baanknet.com) / using his/her mobile number and email-id

Step 2: KYC verification: As a part of e-KYC the documents will be verified by the system. Please note that Steps 1 & 2 should be completed by bidder **well in advance**.

Step3: EMD amount: The interested Bidders/Purchasers have to transfer the EMD amount using online mode (i.e. NEFT/Transfer/UPI/Net Banking) in his Global EMD Wallet well in advance. In case EMD amount is not available in Global EMD Wallet, system will not allow to bid. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance. Bidders may give offers either for one or for all the properties.
