2. EMD Payment: The intending Bidders/Purchasers are requested to register on portal (<https://ebkray.in>) using their email-id and mobile number. The process of e-KYC is to be done through Digilocker and after completion of KYC verification; the intending bidders/Purchasers may login and make the EMD payment. 3. 4. Bidder's e-Wallet should have sufficient balance equivalent to or above the EMD amount at the time of bidding.
