A labourer was killed and another was injured after the roof of a dilapidated government school building collapsed during demolition work in Jabalpur on Tuesday morning.

The incident occurred at Kantora Government Middle School in Kantora village under the Pean Police station area while workers were demolishing the old structure. The roof suddenly gave way, snapping two labourers under the demolition of the abandoned structure.
