Patna: Cops attacked, vehicles torched in protest after mishap

Patna, July 7

THE DEATH of a man in a road accident in Patna on Friday triggered violent protests during which several vehicles were set ablaze, a traffic police outpost was reportedly vandalised, CCTV cameras were damaged, and police personnel came under stone-pelting. Several people, including journalists, were reportedly injured. The incident reportedly occurred near Masaurhi Mor on

National Highway-30 in Patna City after the victim, identified as Manish alias Upendra, aged around 27, was hit by a vehicle while he was trying to cross the road. According to local residents, the victim was a resident of neighbouring Pahari Mohalla in Takiya village, and news of the accident drew a large number of people to the spot. Protesters placed the victim's body on the highway and blocked traffic, demanding action. The protest soon escalated, with sections of the crowd reportedly turning violent.

Protesters allegedly set a bus on fire and vandalised several vehicles. Sources said it was this private bus that had hit Upendra although police is yet to confirm it.

More than half-a-dozen vehicles were reportedly damaged in stone-pelting, while a few belonging to the district administration were also reportedly torched. At least three to four motorcycles were set ablaze. CCTV cameras installed in the area were reportedly damaged, and a traffic police outpost was vandalised. Police are investigating the incident and ascertaining the scale of the damage.

Tamil Nadu CM Vijay's wife Sangeetha withdraws divorce petition

Chennai, August 7

TAMIL NADU Chief Minister C Vijay Joseph's wife, Sangeetha, has withdrawn her divorce petition before a family court in Chengalpattu, near Chennai, bringing to a close, at least for now, a case that had drawn considerable public attention.

According to an order passed by the Single Judge of the Family Court, Sangeetha appeared through video conference and confirmed she did not wish to pursue the matrimonial proceedings initiated earlier this year.

"The petitioner appeared through video conference and confirmed she does not wish to proceed further with this case... and has filed this withdrawal petition," the court recorded.

The court also noted that notice had been served on the respondent's counsel, who recorded no objection to the request. It subsequently permitted the petitioner to withdraw the petition.

"The petitioner is permitted to withdraw this case... with a liberty to file a fresh petition in future, if required. Hence, this petition is allowed," the order said.

Since the petition has been withdrawn rather than decided, the court has not examined or ruled on the allegations or claims originally made in the case.

Friday's order, however, offers no explanation for the decision to withdraw the petition.
