

Senate panel slaps contempt charge on Anthony Fauci

Constitutional protection did not apply since Fauci last year received pardon from Joe Biden: Rand

WASHINGTON

A Senate committee on Thursday voted to hold Dr Anthony Fauci in contempt of Congress and refer him to the Justice Department for potential prosecution over his refusal to answer questions at a hearing last week focused on his handling of the COVID-19 pandemic.

The party-line vote approving the contempt resolution came a week after Fauci invoked his Fifth Amendment right against self-incrimination more than 100 times when he appeared before the Senate Committee on Homeland Security.

Republican Senator Rand Paul of Kentucky, the committee chairman, said that constitutional protection did not apply since Fauci last year received a pardon from Democratic President Joe Biden and thus did not have to worry about the threat of prosecution. Fauci and Democrats who opposed the contempt resolution said he had a well-founded fear of self-incrimination given a

public desire by Republicans to seek his prosecution. "Dr Fauci faced no risk of federal prosecution," Paul said at the outset of a hearing. "All he had to do was tell the truth."

Paul noted that the vote had nothing to do with Fauci's policies, opinions or anything he has said in previous congressional appearances.

Instead, the senator said, "We are voting on whether a witness who has received the benefit of a sweeping pardon can be ordered by this committee to answer questions and then defy that order without consequence."

Iran vows to 'black out' Gulf if USA strikes

RIYADH

IRAN intensified its threats towards its Gulf neighbours last week, conveying messages that it would "black out" the entire region if the United States struck its power plants and rattling off a list of specific targets, two officials told AFP.

The warning followed threats by US President Donald Trump of a massive attack against Iran, which he later walked back over the weekend citing requests from Saudi Arabia, the UAE and Qatar for a breakthrough in talks.

"Iran threatened to black out the Gulf, country by country, if Trump attacked its power plants," a Gulf official told AFP, with another regional official confirming messaging.

Trump said the planned strikes would have been "the biggest attack since World War II", with US media reporting he was considering hitting energy infrastructure, as he has repeatedly threatened to do.

Iran conveyed through intermediaries that any attacks on its power plants would trigger strikes on the same targets in Gulf. **AFP**
