M/S,SULTANA DRESSES (Borrower) availed Loan facilities from **Indian Bank, Vidyanagar Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties", **M/S,SULTANA DRESSES (Borrower), Address : Vill-Jamira, P.O-Gopalpur, P.S-Falta South 24pargna, Pin-743504** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **25.08.2021** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Mortgagor, Guarantor(s) of **M/S,SULTANA DRESSES (Borrower)** to pay the amount due to the tune **Rs. 910326.15 (Rupees Nine Lakhs Ten Thousand Three Hundred Twenty Six and Fifteen Paise)** as on **25.08.2021** and with further interest, costs, other charges and expenses thereon till realization of dues. Both failed to make payment despite Demand Notice dated **25.08.2021**.

As **M/S,SULTANA DRESSES (Borrower)** failed to make payment despite Demand Notice, the Authorised Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities followed by physical possession on **17.11.2021**.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. As per Rule 6 (2), Rule 8(6) and Rule 9 (1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice. The amount due is **Rs. 910326.15 (Rupees Nine Lakhs Ten Thousand Three Hundred Twenty Six and Fifteen Paise)** as on **25.08.2021** with further interest, costs, other charges & expenses thereon due to the Indian Bank.
