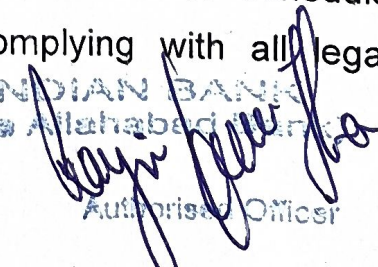

M/s Bajrangi Automobiles (Prop- Mr. Rajinandan Prasad) availed Cash Credit facility from Indian Bank, Pachtakiyadu Branch the repayment of which are secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Bajrangi Automobiles (Prop- Mr. Rajinandan Prasad) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 02.05.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) M/s Bajrangi Automobiles (Prop- Mr. Rajinandan Prasad) and its Guarantors are liable to the Bank to pay the amount due to the tune of **Rs.1,02,45,590/- (Rupees One Crore Two Lac Forty Five Thousand Five Hundred Ninety Only)** as on **02.05.2025** with further interest, costs, other charges and expenses thereon from 02.05.2025 till realization of bank's dues. Both failed to make full payment despite Demand Notice dated **02.05.2025**.

As M/s Bajrangi Automobiles (Prop- Mr. Rajinandan Prasad) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **18.07.2025** after complying with all legal formalities.

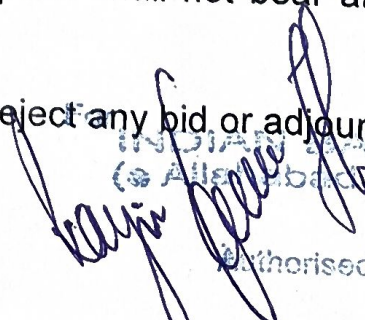
The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

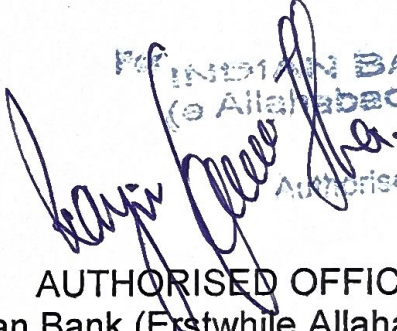
