Sri. Sanjay Kumar Jaiswal (Borrower and Mortgagor) and Sri Guddu Jaiswal (Borrower cum Mortgagor) and Mrs Radhika Kumari W/o Sanjay Kumar Jaiswal availed Housing Loan facility from Indian Bank Mahengaon Branch, the repayment of which is secured by Mortgage of schedule mentioned property hereinafter referred to as "the Properties". THE SALE PROPOSED TO BE HELD IS BY WAY OF AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **20/08/2026** is **₹ 13,11,004.00 (Rupees Thirteen Lakh Eleven Thousand and Four only)** with further interest, costs, other charges and expenses thereon from **21/08/2026**.

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 07/09/2026 which would be by e-auction mode.

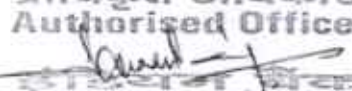

Ltd.)) for **depositing in bidders EMD Wallet**. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted**. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/postpone/ cancel the sale without assigning any reason therefore.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer.
