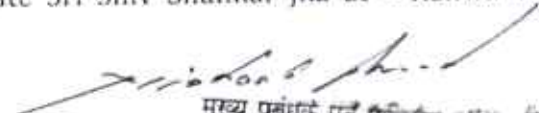

The amount due as on 21.08.2026 is ₹. 28, 53,364.00 (₹.Twenty Eight Lakhs Fifty Three Thousand Three Hundred Sixty Four only) with further interest, costs, other charges and expenses thereon from 21.08.2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 25.09.2026 which would be by e-auction mode.

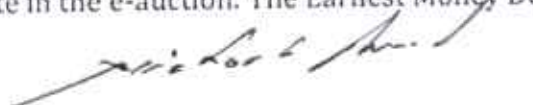

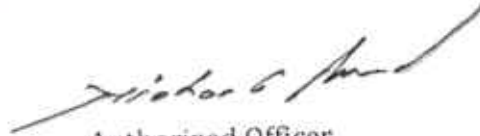
